On December 6, the [National Day of Remembrance and Action on Violence Against Women](#) we remember the 14 women killed at [École Polytechnique](#) de Montréal in 1989, and all the women who have been victims of violence. With the increase of domestic violence and femicides, we must work towards systemic changes and providing support services, to restore womens' rights.

The actions being taken by leaders across Canada are creating change! Recognizing the [United Nations International Day of Disabled Persons \(Dec. 3\)](#), [World Human Rights Day \(Dec. 10\)](#), and [Anti-Bullying Day \(Dec. 17\)](#) are important ways to raise the visibility and awareness of the issues older adults face and the actions each of us can take to be part of the solution, to be more inclusive and accessible.

Canadian Coalition Against Ageism



Elder Abuse Prevention Ontario joined the Canadian Coalition Against Ageism (CCAA).

Formally launched Nov 29-30th, in Toronto, under the leadership of [the International Longevity Centre-](#)

[Canada](#), EAPO met with national partners like *International Federation on Ageing, HelpAge Canada, CanAge, COSCO, United Way British Columbia Healthy Aging, the*

National Pensioners Federation, National Association of Federal Retirees, the Canadian Network for the Prevention of Elder Abuse, and Retired Teachers of Ontario to develop and implement strategies that will help combat ageism.

The CCAA is focused on strengthening, protecting and promoting the human rights of older adults and encouraging the Canadian government and the United Nations to support recommendations from the World Health Organization's [Global Report on Ageism](#), to declare a [UN Convention for the Rights of Older Adults!](#)

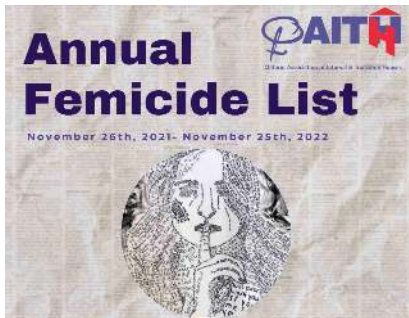

magnitude of ageism, its determinants and its impact.

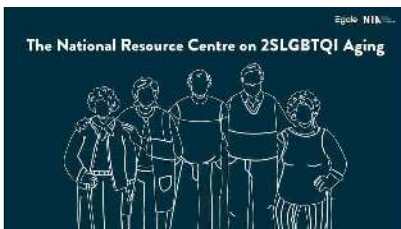

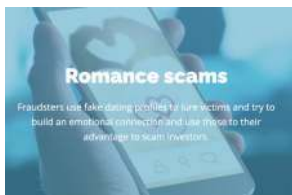
Ontario Francophone Elder Abuse Prevention Network Announced

Through educational forums and tailored training sessions, EAPO continues to raise awareness and is helping build community capacity in francophone communities, to deal with the increasing complexities of elder abuse.

Government of Canada releases 2022 Fall Economic Statement

Prior to the 2022 Fall Economic Statement, this year, Canadians have already been receiving significant new support through the government's Affordability Plan. This includes: Increasing the Old Age Security (OAS)

pension by 10 per cent for the most vulnerable seniors, people 75 years and older, which began in July 2022, will provide more than \$800 in new support to full pensioners over the first year, and increase benefits for more than three million seniors.
