

#### Public Education and Awareness

A Province-wide, multi-media public education campaign to promote awareness about elder abuse and provide information on how to access services.

#### **Training for Front-Line Staff**

Specialized training to staff from various sectors, who work directly with seniors, to enhance their knowledge and skills to recognize and respond to elder abuse.

#### **Co-ordination of Community Services**

To strengthen communities across the province by building partnerships, promoting information sharing and supporting their efforts to combat elder abuse.

# Project Monaco The Grandparent Scam

2022-03-01

# Occurrences



- To date, Durham Regional Police has logged **65 grandparent scam reports**
- Calls are being received on a land line
- Money is being picked up in person at the victim's home
- Address is already known by the suspect(s)
- \$9000 is the amount of cash they routinely ask for
- Victim's receiving phone calls from phone numbers that return to plazas in Quebec
- ALL REPORTS ARE BEING ENTERED INTO POWERCASE FOR EASY TRACKING AMONGST OTHER JURISDICTIONS – PLEASE CONSIDER THIS IF YOU ARE EXPERIENCING THESE INCIDENTS!

## **DRPS** Investigation

- Communications requested to contact Financial Crimes immediately upon receiving call of this nature
- December 15, 2021 Call received at residence in Oshawa
- Financial Crimes team deployed to conduct surveillance
- Silver SUV observed in area and plate obtained
- Caller felt "heat" and terminated the scam



## **DRPS** Investigation

- December 16, 2021 another call in Oshawa
- FCU notified and the plate information from the suspect vehicle the day prior broadcast
- Responding officers observed the same SUV outside the r and arrested the lone occupant



# Suspect Debrief

- Suspect described his role as "driver"
- Sent to addresses by a "dispatcher"
- Paid \$250-300 per pick up
- Suspect phone seized and communications with "dispatcher" confirmed – "LK"
- Phone number located and found to be active



# Tracker

- Production Order for subscriber information obtained
- Tracking warrant for phone obtained
- Suspect Identified
- Warrant executed at the suspects residence
- Electronic devices seized and analyzed
- Items found in electronic devices confirmed involvement

And linked the suspect to other incidents.



### **Next Steps**

- Seek production orders for banking information
- Investigate further contacts of the known suspects and their possible involvement in the scheme.



# Challenges

- Multi jurisdictional investigations
- Upon information from various incidents in different areas resulting in arrests, the information, such as phone numbers, is shared and analyzed in order to determine possible connections
- Gathering all of the information is important to the success of any investigation. In these investigations, phone numbers, statements and video surveillance can prove to be very
- Education and information.



# Protecting Yourself and Others

- Ask questions only family members would know
- Don't be afraid to say no
- Avoid pressure tactics
- Know who you are dealing with
- Never send money, gift cards or cryptocurrency to someone you don't know
- Never give personal or financial information over the telephone / Internet
- Check your credit report regularly!



# Protecting Yourself and Others

- Change your passwords frequently
- Review your privacy and security settings on social media
- Don't respond to suspicious texts or pop-up windows.
   Delete immediately!
- Be careful who you share images with on phone and social media

### **RCMP, OPP**


Report the fraud or scam incident to your local law enforcement to ensure they are aware of the scams that are targeting the area.

Request from each agency a copy of your credit report and then review it carefully to see if a scammer opened any accounts or incurred debt in your name. Also ask to put an alert on your credit report in case future scam attempts are made under your name.






