

IMPORTANT

- An Income Tax and Benefit Return is a multi-purpose form used to:
 - pay income tax
 - claim a refund if we overpaid income tax
 - apply for tax credits and benefits



Completing the return

- Identify yourself
- Calculate your total income
- Claim deductions to determine net + taxable income



- Claim Ontario benefits



Identify yourself

- Name
- Address
- Email address
- Social insurance number (SIN)
- Date of birth
- Marital status
- Language
- Spousal information



Calculate your worldwide income

- Use Information slips and/or self-employment records
- Skip this step if you have no income

- Old age security pension (Line 11300)
- Canada pension plan benefits (Line 11400)
- Other pensions including pensions from other countries (Line 11500)
- RDSP income (Line 12500), RRSP income (Line 12900), RRIF income (Line 1300)
- Dividends (Line 12000 Line 12010)
- Interest (Line 12100)
- Capital gains (Line 12700)
- Rental income (Line 12600)
- Self-employment income (See Guide T4002

Determine your net and taxable income

- You can reduce your income by claiming certain expenses as deductions
- Here are some examples

- RRSP contribution (Line 20800)
- Moving expenses (Line 21900)
- Pension splitting (Line 21000)
- Carrying charges, interest expenses (Line 22100)

Calculate your federal and Ontario tax payable

- Tax preparation software automatically calculates your tax and Ontario Health Premium (OHP)
- Higher tax and OHP rates apply to higher amounts of income

Federal income tax rate

15% on your first \$55,866 of income 2024

Ontario income tax rate

5.05% on your first \$51,445 of income



Non-refundable tax credits

- Lower your tax payable
- Available federally and provincially
- Both governments have unique credits
- Unused credits are not refunded
- Some can be transferred to another family member or carried forward to a future year

Examples of non-refundable tax credits

- Basic personal amount
- Spouse or common-law partner amount
- Age amount
- Pension income amount
- Caregiver amount
- Disability tax credit
- Medical expenses tax credit
- Low-Income individuals and Families Tax (LIFT) Credit

Low-Income Individuals and Families Tax Credit

- Up to \$875 each year in Ontario personal income tax relief
- Must be a Canadian resident in any province or territory at start of the taxation year and an Ontario resident by end of the taxation year
- Must have employment income and owe Ontario personal income tax

Refundable tax credits

Refundable credits:

- ✓ Lower your tax payable
- ✓ Payable even if you don't owe tax

Benefits:

✓ Financial assistance for various expenses and situations

Some refundable tax credits and benefits are paid separately

Ontario Seniors Care at Home Tax Credit

- Refundable tax credit for seniors 70 and older
- Effective January 1, 2022
- Based on medical expenses claimed for existing Ontario
 Medical Expense tax credit
- Receive 25% of claimed medical expenses up to \$6,000
- Amount reduced by 5% of family net income over \$35,000 and fully phased out at \$65,000



Ontario Seniors' Public Transit Tax Credit

- Refundable tax credit
- Claim up to \$3,000 in eligible expenses and receive up to \$450 each year
- Eligible expenses include:
 - -Conventional public transit services
 - -Specialized public transit services designed to transport people with disabilities
 - -Single-ride tickets or tokens

Examples of federal amounts

GST/HST credit

- Helps individuals and families offset GST/HST they pay
- Up to \$519 (single) or \$680 (married or have a commonlaw partner) - July 2025 to June 2026

Canada Carbon Rebate (formerly Climate action incentive payment)

- Helps individuals and families offset cost of federal pollution pricing
- \$560 for an individual plus \$280 for a spouse or commonlaw partner
- To claim rural supplement, complete question on page 2 of tax return

Multigenerational home renovation tax credit

- Assists with renovation costs to create secondary unit that allows senior or adult eligible for disability tax credit to live with qualifying relative
- Claim up to \$50,000 in qualifying expenditures, up to a maximum credit of \$7,500

The final result...

- After you calculate your income and taxable income, tax payable, claim your tax credits, you will know whether you:
 - Are eligible for a tax refund
 - Still owe some tax
- Review your return for completeness, then send it to the CRA
- Once processed, the CRA will send you a Notice of Assessment

Claim Ontario's benefits

Benefits:

-Financial assistance for various expenses and situations

-Some are paid separately from tax refund

Ontario Trillium Benefit

Ontario Sales Tax Credit

- Up to \$360 per person

Ontario Energy and Property Tax Credit

- Up to \$1,421 to help with sales tax on energy and with property taxes
- Do not claim if you lived in social housing unit exempt from property tax

Northern Ontario Energy Credit

 Up to \$277 per family / \$180 per single person to help with higher home energy costs faced by Northern Ontarians



Ontario Senior Homeowners' Property Tax Grant

- Helps low-to-moderate income seniors with cost of their property taxes
- Up to \$500 each year
- To be eligible, on December 31 of previous year you or your spouse/ common-law partner must:
 - -be at least 64 years old
 - own and occupy your home in Ontario
 - have paid property tax for your home

Ontario 😚

Keep your supporting documents, such as:

- Information slips (such as T4-A slips)
- Donations
- Home accessibility expenses
- Medical expenses
- Public transit costs
- Rent / Property tax



Filing options

- Use CRA-approved tax software to calculate and file taxes electronically
- Get free help through a community volunteer tax clinic
- Use SimpleFile by Phone automated phone service
- Hire a tax preparer
- File a paper return



How to change a return



- You can request a change to a return for a tax year ending in any of the 10 previous calendar years
- For example, a request made in 2025 must relate to 2015 or a later tax year
- Wait until you receive your notice of assessment before asking for changes to your return
- Use CRA's My Account service or complete a T1 Adjustment Request form

GAINS – Guaranteed Annual Income System

As of **July 2024**:

- Maximum benefit is \$87/month (single) / \$174/month (couple)
- You qualify for GAINS if you:
 - ✓ are 65 years or older
 - have been a Canadian resident for 10 years or more
 - ✓ lived in Ontario for the past 12 months or total of 20 years since age 18
 - receive federal Old Age Security (OAS) pension and Guaranteed Income Supplement (GIS) payments
 - ✓ have annual private income of up to \$4,176 (single) or \$8,352 (couple)
 - have filed your personal Income Tax and Benefit Return



Examples of Ontario benefits

- Ontario Drug Benefit Program
- Reduced Co-payment for Lower Income Seniors
- Ontario Seniors Dental Care Program
- Long-Term Care Rate Reduction Program
- Canada-Ontario Housing Benefit
- Assistive Devices Program



Examples of federal benefits

- Canada Pension Plan (CPP)
- Old Age Security (OAS)
- Guaranteed Income Supplement (GIS)
- Allowance for people aged 60 64
- Allowance for the Survivor
- Canada Dental Care Plan



Credits and benefits change over time

- Review the tax return, including the 'What's New' sections
- Pay attention at budget time
- Explore helpful government resources



Don't get scammed

Government departments do not:

- Use aggressive language or demand immediate payment over the phone
- Ask you by email for personal information, bank information or payments by e-transfers or gift cards
- Use text messages or instant messages to start a conversation with you about your taxes, benefits or refund

Not sure what to do?

Do not:

- reply to texts or click links in text messages
- provide anyone with your personal or financial information
